

## Recreational Opportunities

Archery Range – Fishing - Hiking - Hunting - Wildlife Viewing

Conservation areas are closed from 10 p.m. to 4 a.m. except for authorized camping, fishing and hunting activities.

- No littering, No fireworks, No open fires, except in designated areas.
- No free-running pets. Dogs must be leashed or confined when not being trained or used for hunting.
- Destroying, cutting or removing vegetation is prohibited. Nuts, berries, fruits, mushrooms and wild greens may be taken for personal consumption only.
- Motor vehicles are restricted to graveled roadways and parking areas.
- Primitive camping is permitted only in designated areas and is limited to 14 consecutive days in a 30-day period. 30 day maximum stay per year. Groups of 10 people or more must obtain a special use permit.
- Bicycles allowed on designated service roads year-round. Service roads can be located at <https://mdc.mo.gov/discover-nature/places>. Horses and horseback riding are permitted only on roads open to vehicles.
- Firearms target shooting prohibited. Archery target shooting on designated shooting range only.
- Swimming, scuba diving, water skiing, sailboarding, skateboarding, caving and rappelling are not allowed.

## Fishing and Boating

Fishing is permitted under statewide regulations. The following special regulations also apply.

- Fish may be taken only by pole and line and no more than three poles and lines may be used by any one person.
- Daily limits are six black bass and four catfish in the aggregate (channel, blue and flathead catfish), and 30 crappie. All other fish, statewide limits, but the total number taken may not exceed 20.
- All black bass between 12 and 15 inches in total length must be released immediately after being caught.
- Fishing is permitted in area streams under statewide regulations.
- Bullfrogs and green frogs may be taken during the statewide season only by hand, handnet, atlatl, gig, bow, snagging, snaring, grabbing, or pole and line, a twenty-two (.22) caliber or smaller rimfire rifle or pistol, pellet gun, or crossbow, only on waters and within dates and hours those waters are open to fishing or hunting.
- Seining or trapping live bait, including tadpoles, is prohibited on all lakes and ponds.
- Boats may not be stored or left unattended overnight.

- Electric motors only are allowed.

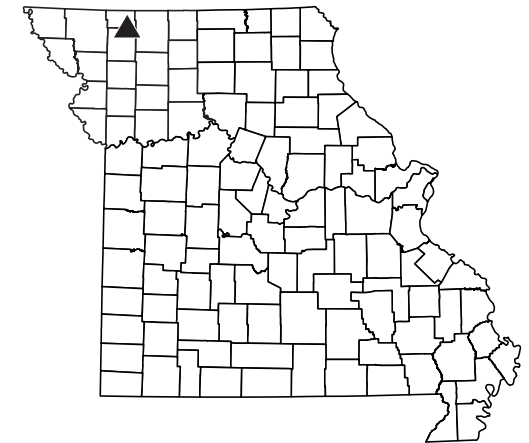
## Hunting and Trapping

Area is open to hunting under statewide regulations. The following special regulations also apply. Deer and turkey regulations are subject to annual changes. Refer to Spring Turkey or Fall Deer and Turkey booklets for current regulations.

- Trail and game camera's are prohibited.
- Only portable tree stands are allowed and only from Sept. 1 through Jan. 31. Unattended stands must be plainly labeled with the full name and address, or Conservation Number, of the user and be removed from the area before Feb. 1. Use of nails, screw-in steps, and any material or method that would damage the tree is prohibited.
- Decoys and portable blinds are permitted but must be removed from the area daily. Blinds may be constructed on-site, but only from willows and non-woody vegetation.
- Trapping of furbearers is permitted only with a special use permit.
